Subject :- Requests for providing New Gate between Auditorium and High Court campus and allotment of additional space to Association.

Reference:- Building Committee decision dated 07.02.2023.

Sir,

With reference to subject noted above, I am to inform you that the requests made by the Gujarat High Court Association have been considered by the Hon'ble High Court Building Committee in the meeting held on 07.02.2023.

The first request made by the Association for making provision of entrance for vehicles by providing a new gate by breaking open some portion of the common wall of Auditorium and Gujarat High Court Complex behind the State Legal Service Authority Building has been accepted by the Hon'ble High Court Building Committee subject to following conditions:

1. The iron-gates separating the indoor parking areas and the front side open area of the Auditorium shall remain closed throughout. This would ensure that the vehicles enter the indoor parking areas of Auditorium from proposed new gate only after security check at the main gates of the High Court campus. The vehicles which enter from the main gates of the Auditorium for parking in open space as per prevailing arrangement would be allowed to park only in open parking area of the Auditorium.
2. Additional security/police personnel shall be deployed to thoroughly check the vehicles and allow entry for cars in the indoor parking area of Auditorium only with stickers of "Gujarat High Court Advocates' Association" and also to ensure proper parking arrangement.

3. The parking in indoor parking areas of Auditorium as well as access of entry and exit from the proposed gate shall be allowed from 10:00 am to 6:00 pm only and in any case, overnight parking of vehicles shall not be permitted at any place in the campus of Auditorium. For the breach of this condition on first and second occasion, such vehicle shall not be permitted to be parked in any of the Cellars for a period of one and two weeks respectively whereas for the third such breach, the concerned vehicle would be permanently debarred from entering the indoor parkings of the Auditorium.
4. The entry inside the Auditorium building from the stairs or lift of indoor parking levels shall remain closed.
5. The arrangement to be made by the High Court from time to time for smooth entry and exit of vehicles inside the High Court campus to avoid decongestion of traffic during peak hours shall have to be followed.
6. The drivers / advocates / anyone else shall not be allowed to linger on in the indoor parking area or inside the Auditorium.
7. The President and Secretary of the Gujarat High Court Advocates' Association shall ensure that the open as well as indoor parking area of the Auditorium as per proposed arrangement shall not be utilised by its members as and when so required by the High Court administration.
8. The President and Secretary of the Gujarat High Court Advocates' Association shall ensure that aforesaid conditions are strictly complied with by members of the Bar.

I am to further inform you that the decision with regard to the second request made by the Association for allocation of more space adjoining the Association Office on the First Floor of A-Wing of Old Advocates' Building has been deferred.
